2. **GENERAL INSTRUCTIONS**

6.0 PERFORMANCE BOND

- 6.1 The successful bidder will provide Performance Bond at the rate of 10% of CFR Value of the contract in favour of Wah Industries Ltd. The Performance Bond will be furnished in the form of CDR / Pay Order or an unconditional bank guarantee on prescribed Proforma covered by any scheduled bank in Pakistan. If the Performance Bond is not furnished within the a/m prescribed time, the Purchaser reserves the right to cancel the contract and has the right of risk purchase action.

7.0 FAILURE TO SUPPLY THE STORES:

All the deliveries must be completed by the specified date. If the failure to deliver the stores within the scheduled time should have arisen from "Force Majeure", which the purchaser may admit as reasonable ground for further time, he will allow such additional time as he may consider to have been required by the circumstances of the case. 8.0 PAYMENT:

LC will be amended accordingly. The following information will be provided by the supplier, after metal purchased against the order.

- 8.2 Payment shall be made by means of irrevocable Letter of Credit All Bank charges incurred in Pakistan in connection with the establishment of L.C. shall be borne by the purchaser; whereas, all Bank charges incurred in connection with drawing of payment including charges for confirmation of L.C. by the advising Bank/Foreign Bank shall be borne by the supplier.
